A legacy or planned gift is one way you can make this possible. You will ensure that your legacy is remembered in your community forever.

Each type of planned gift has its benefits for you and your family. All gifts make a difference in improving patient care here at St. Joseph's Health Centre.

MAKE A BEQUEST IN YOUR WILL

You want to make sure the most important people in your life are taken care of when you're gone. You can also help take care of your friends and neighbours in your community by leaving a bequest to St. Joseph's.

Benefits of naming St. Joseph's in your will

- *You retain full control of your assets during your lifetime.*
- *Your cash resources won't be affected while you need them.*
- *The final taxes to be paid on your estate can be significantly reduced, which can be a big advantage for your heirs and a great comfort to you.*
- *You can leave a bequest for your loved ones and support St. Joseph's at the same time.*

There are different types of bequests. Choose the one that best suits you. Designate a specific gift amount, or contribute a portion of your estate's assets. Upon receiving the bequest, St. Joseph's will issue a donation receipt to your estate for the full amount of the bequest. Sample bequest language to share with your advisor is available from the Foundation Office.

GIVE APPRECIATED SECURITIES

You can make a donation of marketable securities like stocks, bonds or mutual funds to St. Joseph's during your lifetime or through a bequest. The Government of Canada has eliminated the capital gains tax on the charitable donation of publicly listed securities when the securities are donated directly to the Health Centre instead of selling the securities first. DONATE LIFE INSURANCE, RRSPS & RRIFs

Gifts of a new or existing life insurance policy can be made by naming St. Joseph's Health Centre Foundation as the beneficiary or by transferring ownership of a policy to the Foundation. This support builds towards a sizeable gift in the future by making relatively small premium payments today.

St. Joseph's Health Centre Foundation can also be named as the beneficiary or alternate beneficiary, after your spouse, on RRSPs and RRIFs.
